WHEREAS, the Agency board desires to authorize the preparation of a draft economic development project area plan and draft economic development project area budget for a proposed economic development project area known as the Eagle Mountain Economic Development Project Area #2012-1, as generally described by parcel numbers and map attached hereto in Exhibit A and Exhibit B, respectively.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE EAGLE MOUNTAIN REDEVELOPMENT AGENCY that the Agency and its staff are hereby authorized to:

- 1. Prepare a draft economic development project area plan for the proposed Eagle Mountain Economic Development Project Area #2012-1;
- 2. Prepare a draft economic development project area budget for the proposed Eagle Mountain Economic Development Project Area #2012-1;
- 3. Obtain whatever information is necessary, and hire or contract with consultants and others as necessary for the preparation of the draft economic development project area plan and budget; and
- 4. Take other and additional actions necessary or prudent in considering and creating the proposed economic development project area in compliance with the Act.


