FROM THE MAYOR'S DESK



This month I would like to express my thanks in two separate areas: first, to some very dedicated citizens and organizations and second, to some very dedicated city staff members.

First, as a result of a lot of work by citizens and organizations, an awards benefit was held this month for *Home for a Hero*. Sergeant First Class (SFC) Gordon Ewell is a local military service hero from Eagle Mountain who sustained severe and multiple injuries in his military service, rendering him unable to return to work.

In recognition of SFC Ewell's heroic service, *Home for a Hero* (see story on page 4) is building a home for SFC Ewell and his family. This event inspired greater appreciation for our country and those who defend it. There are many unsung heroes among us. Often, the dedicated efforts of a relatively few have tremendous impact upon many; and we are all beneficiaries of those who give and sacrifice for our nation and our local community.

Secondly, as a result of a lot of work by dedicated city staff, Eagle Mountain is the recipient of the national "Distinguished Budget Presentation Award Program (Budget Awards Program)" for our 2007 – 2008 City Budget. This is another first for the City and puts our budget at a new professional standard.

Other events in the city this last month include the ground-breaking for a new elementary school in Hidden Valley, Well #4 and Well #5 currently under construction, and plans for a spring 2008 ground breaking for the commercial area where the Associated Foods Store will be built.

In this election month, I appreciate the votes you will cast-- they will shape the future of our city. Also, to provide you with an account of the current state of the city, we will be holding a Town Hall Meeting on November 15th. John Hendrickson and I will be there to answer questions and listen to your hopes for the upcoming year.

EAGLE MOUNTAIN JOINS ECONOMIC **DEVELOPMENT CORPORATION OF UTAH Commercial Prospects For City Increasing**

Eagle Mountain City is now a member of the Economic Development Corporation of Utah (EDCU) and has received a \$4,000 grant to develop marketing materials in an effort to continue to attract more businesses to the community.

The EDCU is a public/private partnership started in 1987 that works with state and local governments and private industry to attract competitive, high-value companies and aid in the development and expansion of local Utah businesses. They currently serve 26 cities and 8 counties in Utah.

Along with the grant the city has received, our new partnership with EDCU enabled managers from our city to represent Eagle Mountain at the International Council of Shopping Centers convention in Las Vegas - one of the biggest commercial conferences in the world. The city has also listed land that is available for commercial development to prospective tenants on www.utahsuresites.com, an EDCU affiliated website.

Membership in the EDCU is another step Eagle Mountain City is taking to expand its growing commercial base. The city is in the process of finalizing an agreement with Associated Foods for a grocery store that is expected to begin construction in Spring 2008. A Maverik station is currently under construction and other imminent projects include an auto shop, a car wash, another dental office, and a new professional office building. The city is also working with developers to set aside land for light industrial companies.

"Joining the EDCU is just one of the many ways in which we are working to bring economic development into our City," Mayor Don Richardson said. "New businesses will bring jobs, convenience, and tax dollars to Eagle Mountain."

NEW HOME AWARDED TO WAR HERO

Sergeant First Class Gordon Ewell, a 22 year veteran of the military who is now coping with the results of serious injuries he received while serving in Iraq, was announced as the recipient of the "Home for a Hero" project on September 29.

Rain and snow did not dampen the occasion as family, friends, co-workers, community members, and dignitaries attended the event (relocated from Nolan Park) at The Ranches Academy.

In spite of the weather, a groundbreaking ceremony was held, complete with dirt that was transported from the new home site to a makeshift pit on the indoor stage.

SFC Ewell and his family, wife Terra and their six children, will receive a new home courtesy of local builder Alta Vista Homes, Homes for Our Troops, a non-profit based in Massachusetts, and Mike's Guardian Eagle Foundation, a Utahbased non-profit.

Ewell was one of three nominated soldiers who all received life-changing injuries while serving in Iraq. He was a route

clearance expert who tracked Improvised Explosive Devices (IEDs) - the biggest cause of injury and death to soldiers in the current war. Ewell actually wrote the training manual for tracking IEDs, which has saved countless lives. He sustained direct hits to his vehicle six times and is now suffering from traumatic brain injury, permanent hearing loss, partial blindness, a reconstructed jaw, and has difficulty with coordination, walking, and standing.

In spite of his new struggles, Ewell is humble, optimistic, and grateful for his opportunity to serve his country.

"Sometimes I still want to go back out there," Ewell said at the ceremony. "There's still bombs that need to be found." The Ewell family currently rents a home in Eagle Mountain. Their new home will be located in the Lone Tree subdivision. Paul Gemme, senior project manager for Homes for Our Troops, expressed hope that perhaps their new home, which will be specially designed to accommodate Ewell's disabilities, could be completed by Christmas.

Alta Vista Homes, who spearheaded the project, has received donations of building materials and labor from local contractors, in addition to the help they are receiving from the two non-profits. The Eagle Mountain City Council also recently voted to waive all building fees associated with the project. However, help is still needed, and a benefit concert is being organized by Alta Vista to get more people in the community involved (see box below left).

Dump Passes & Recycling — Residents are reminded that the city offers two free passes to the dump per household per year. The passes are available at the Planning Department office in City Hall, 1650 E. Stagecoach Run, Monday through Thursday from 7:30 AM to 5:30 PM. The dump is located at 2000 West 200 South in Lindon. Phone: 225-8538

Those who are interested in recycling may use the recycling dumpster at the city's fire station #2, 3785 E. Pony Express Parkway in The Ranches. This dumpster is suitable for paper, cardboard, plastic, and aluminum recycling. No glass or liquids are allowed. If the dumpster is full, please do not leave items outside of the dumpster. The dumpster is emptied every first and third Wednesday of the month.

Lost or Stolen Trash Cans — Allied Waste has revised their charges for replacement of lost or stolen trash cans. The charge is now \$50 if the resident files a police report and submits it to Allied Waste. Without a police report, the replacement fee is \$100.

Allied Waste will repair or replace trash cans if needed due to normal wear and tear or damage caused by their company during operations

NEW ELEMENTARY SCHOOL TO OPEN FALL 2008

Eagle Mountain's full elementary schools will receive some relief next fall, as construction has begun on the city's newest elementary school. The site is located on Pony Express Parkway west of the Hidden Canyon subdivision in The Ranches.

The Alpine School District hosted a groundbreaking ceremony for the new school on October 9. Superintendent Vernon Henshaw, Dr. Michael Pratt, and School Board Member Donna Barnes, were among those in attendance.

Representing the city were City Council Members Heather Jackson, David Lifferth, and City Administrator John Hendrickson. Council Member Vincent Liddiard sent his son Scott to stand in for him.

Also on hand, local Boy Scout Troop 1045 conducted the flag ceremony and the Pony Express Elementary Choir, directed by Cindi Arnold, performed.

The school, unofficially named Hidden Valley Elementary, will serve approximately 800 students. It is expected to be open for the 2008-2009 school year.
