### Off-Highway Vehicle Trespassing

Residents on Lake Mountain Road (on the west side of Sweetwater Road south of Unity Pass) are experiencing frequent problems with people riding off-highway vehicles through their property to get to the open BLM land along the mountain. Per city ordinance #00-08, OHVs are not allowed on any city streets.

In addition to violating the city ordinance, damage is being done to the area surrounding the homes on Lake Mountain Road. Residents have reported destruction to their grass, their horses being frightened, fires lit and not extinguished properly, and destruction of snow fences and signs they have put up in an effort to notify people they are on private property.

The Utah County Sheriff's Department—Eagle Mountain Division, is aware of the problem and citations are being issued to any trespassers that are caught on private property or riding on city streets.

The city asks that everyone be respectful of the property of others and obey the city ordinance. OHV enthusiasts are encouraged to travel a short distance west on SR-73 to Five Mile Pass where there is ample space to ride legally.





## FAMILY SEES DAD'S DREAM COME TRUE WITH HELP OF RED SOX FANS



The James Taylor family had big plans for James' 37th birthday in August. They would fulfill a dream of their husband and father, to take his family to see the Boston Red Sox play in Fenway Park.

James Taylor was such a passionate Red Sox fan that when his oldest son Mason was drafted by a little league team called the Yankees, he vowed to coach a team called the Red Sox next year.

However, fate intervened and James was not able to see either of those plans come to fruition. A St. Marks Hospital emergency nurse who also worked part time on the Arizona helicopter medical staff, James was aboard a medical helicopter on June 29 transporting a man who had been injured in the Grand Canyon when the helicopter he was in collided with another medical chopper.

The lone survivor of the crash, James had extensive internal injuries but did not pass away until July 4, a fitting date for an American hero who not only served at home, but abroad - treating the injured from Desert Storm as a first lieutenant in the US Army Reserves.

Following James' passing, the Taylor's extended family wanted to do what they could to help his wife Traci, and his sons, Mason, 10, Weston, 9, and Jackson, 4—who is autistic, through their grief. They knew the family's medical and funeral expenses would prevent them from pursuing James' dream of taking the family to Boston.

After James' sister Laurie Brady posted the family's story on a Red Sox fan message board, the magic started to happen. Tom Nardozzi, a Red Sox fan from New Hampshire championed their cause. He bought the family eight box seats just above the on-deck circle. A longtime Red Sox blogger, Cyn Donnelly, collected more than \$2,000 in donations from fans as far away as New Zealand. JetBlue donated eight round trip tickets from Salt Lake to Boston.


On August 29, the family arrived at Fenway Park with the boys knowing only that they were going to see a Red Sox game. Instead, they got the VIP treatment, with a tour that included being allowed in the dugout and onto the field pre-game. Mason and Weston were even named honorary bat boys. Once word spread of their visit, the team's big name players including Dustin Pedroia, Jonathan Papelbon, and Jacoby Ellsbury took time to meet the boys, give them autographs, and pose for photos.

After All-Star pitcher Curt Schilling presented the

## RECYCLING DUMPSTER RELOCATED

The recycling dumpster located at the Public Works Building at 2545 Sweetwater Road (City Center) has been moved to the front of the sewer treatment plant (just off the road, outside the gates) while the new sewer treatment facility is being constructed.

Following is a list of acceptable recycling products that may go in the dumpster:

- ◆ Plastic - #1-#7 (milk jugs, soft drink bottles, etc.)
- ◆ Aluminum cans
- ◆ Paper (junk mail, envelopes, magazines, etc.)
- ◆ Newspaper (including phone books)
- ◆ Corrugated Cardboard (broken down moving & shipping boxes, etc.)
- ◆ Paper Board (broken down cereal boxes & other food boxes)

NO glass or Styrofoam is allowed in the dumpster.

The dumpster fills up quickly. Please break down items as much as possible for best use of dumpster space. Also, please DO NOT leave items outside the dumpster. Improper use may cause the City to limit public access to the recycling dumpster.



## UTA ANNEXATION for EAGLE MOUNTAIN and SARATOGA SPRINGS Quick Facts

- If the majority of voters in Eagle Mountain and Saratoga Springs vote "Yes" on Proposition 1, both cities will be annexed into the UTA district.
- Voting "Yes" on Proposition 1 will increase the sales tax in both cities from 6.20% to 6.45%, a 0.25% increase.
- This increase amounts to an average yearly tax of \$0.50 per person, per year.
- The 6.45% sales tax rate is already in effect in area cities such as Lehi and American Fork.
- If this proposition passes, the UTA has said it is very likely that Eagle Mountain and Saratoga Springs will get an express bus route to Salt Lake City, potentially as soon as April of 2009.
- This express bus route will be funded for the first three years by grant money offered by the Mountainland Association of Governments. After that time, the UTA has said there is a possibility of providing connector service from Eagle Mountain and Saratoga Springs to the new rail station at Thanksgiving Point.




