CITY COUNCIL ACTIONS*

October.....

Approved a change order for Mid Valley Completion Project – Staker Parson.

Approved final payments for Mid Valley Completion Project – Staker Parson and 6" High Pressure Natural Gas Pipeline Project – Tempest.

Approved a change order for the 12.47 kV Main Feeders and Gas Lines project in the amount of \$21,391.51.

Adopted a resolution authorizing the issuance and sale of not more than \$2,600,000 aggregate principal amount of Water and Sewer Revenue Bonds, Series 2013.

Adopted a resolution approving the Evans Ranch master development agreement, with the conditions that the agreement is valid for 15 years and the sewer system is consistent with the City's sewer master plan.

Adopted a resolution approving the Evans Ranch master development agreement, with the conditions that the agreement is valid for 15 years, the sewer system is consistent with the City's sewer master plan, and the \$2,000 per buildable acre of community improvement funds be spent on public amenities along the north end of the subdivision.

Adopted a resolution approving the Arrival master development agreement with the following conditions: That the City owns the open space and contract with the HOA to maintain it; that the HOA maintains the trails and trail easements; that the Canyon Road and accessory apartment sections be removed; and that the agreement have a ten-year expiration date. Vote was 3:2 with Council Members Ochsenhirt and Painter voting no.

Adopted an ordinance establishing a Military and Veterans Advisory Board. Vote was 3:2 with Council Members Ireland and Painter voting no.

Approved an improvement purchase agreement with RCA65, LC for the Ranches Parkway Extension project.

Approved an agreement with Matrix Design Group as a consultant for the Camp Williams Joint Land Use Study (JLUS) implementation.

Awarded a bid to VanCon for the CWP Pony Express Pipeline project in the amount of \$2,535,570.00



City receives finance awards

The Government Finance Officers Association of the United States and Canada (GFOA) announced on October 11, 2013 that Eagle Mountain City's Finance and Executive Departments have been awarded the Certificate of Achievement for Excellence in Financial Reporting for the comprehensive annual financial report (CAFR). This is the third consecutive year the City has received this award.

According to the GFOA, the Certificate of Achievement "is the highest form of recognition in the area of governmental accounting and financial reporting, and its attainment represents a significant accomplishment by a government and its management.

The CAFR is judged by an impartial panel to meet the high standards of the program including demonstrating a constructive "spirit of full disclosure" to clearly communicate its financial story and motivate potential users and user groups to read the CAFR.

The City has also received the GFOA's Distinguished Budget Presentation Award for the past six years. According to their website, the GFOA established the Distinguished Budget Presentation Awards Program in 1984 to encourage and assist state and local governments to prepare budget documents of the very highest quality that reflect both the guidelines established by the National Advisory Council on State and Local Budgeting and the GFOA's best practices on budgeting and then to recognize individual governments that succeed in achieving that goal.



Bag the Leaf

Help keep storm drains clear with Bag the Leaf. Following are details about the program and how you can participate:



- Pick up bags at City Hall (reception desk) Mon.-Fri., 7:30 a.m.-5:30 p.m. or The Ranches HOA office, Mon.-Fri., 9:00 a.m.-5:00 p.m. or use your own bags.
- Bags available through November 20 while supplies last.
- Curbside pick-up weekdays through November 22. Email Idiamond@emcity.org to request pick up.

Program guidelines:

- City provided bags as well as other small to large plastic garbage bags may be used to collect your leaves.
- Bags shall not exceed 40 pounds and must contain leaves only. Heavier bags will not be collected.
- The City will not collect any bag(s) that contain household waste, green waste, branches, limbs, rocks, animal waste, dirt, sod or other restricted bulky waste. If a bag contains any unacceptable materials, crews will place a notice on your bag(s) and leave them for you to remove.
- Place your bag(s) curbside. Bags should not be placed in the street, gutter, ditches, or any drainage way. This would obstruct the flow of storm water runoff when it rains.

City Planning Lingo

Here is a quick guide to basic planning vocabulary. If you have ever found yourself confused by the many planning terms used in our city's development, here are some definitions which may help you better understand what is going on within Eagle Mountain. These definitions were taken from the City's development code, the American Planning Association, and Wikipedia.

Zone/Zoning

- Zoning is the division of a city or county into areas, or zones, which specify allowable uses for real property and size restrictions for buildings within these areas. It is the chief land use implementation tool for the City's general plan.
- o A zoning ordinance or zoning code is the legal document that describes each zoning district, the regulations applicable within each district, and a zoning map that depicts each district.

Plat

A map indicating the divisions of land, the proposed layout of a development, and related information. A preliminary plat is the initial
proposed development, and a final plat is the final version which will be recorded with the County following approval.

General Plan

 The adopted document of a legislative body of a local government (City Council) that sets forth (in words, maps, illustrations, and/or tables) goals, policies, and guidelines intended to direct the present and future physical, social, and economic development that occurs within its planning jurisdiction/city boundaries.

Master Development Plan

A plan for development of property that indicates, among other things, density maximums, how property will be developed, phasing, utility service, financial feasibility, vehicular and pedestrian circulation, open space, parks and recreation, trails, and all other requirements of master development plans found in the City's land development code.

Development Agreement

A form of contract between the City and a developer that establishes in detail the specific improvements required as a condition of a
project's approval. Development agreements may also vest certain additional rights with the developer or the City.

Built Environment

o Consists of all buildings, roads, utilities, homes, fixtures, parks, and all other improvements that form the physical character of a city.

Fasement

 A right to use the property of another for a specific, predefined purpose without possessing it. Typically easements exist for the maintenance of public infrastructure, such as water and sewer lines, and for planned future growth, such as future expansion of a roadway.

Variance

o An approved administrative exception or deviation from the basic land use requirements that apply to a property and its structures.

Setback

The minimum required distance between the property line and the building on a lot, excluding porches, window wells, verandas, uncovered decks, and other similar structures. Each lot has front, rear, and side setback requirements.

Frontage

o The portion of a lot extending along a public or private street. This is typically measured along the front property line of a lot.

Development Review

The review and approval process for applications for any of the following within a city: a site development plan, zoning or rezoning, general/preliminary/final development plan, final or preliminary subdivision plat, annexation, variance, master development plan, boundary line adjustment, zoning compliance, or appeal.

Walkability

 A measure of how friendly an area is to walking. Factors influencing walkability include the presence of or absence and quality of footpaths, sidewalks, or other pedestrian rights-of-way, traffic and road conditions, land use patterns, building accessibility, and safety.
