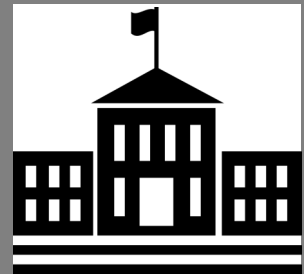

IMPARTIAL ANALYSIS

Constitutional Amendment A modifies a provision of the Utah Constitution relating to special sessions of the Utah Legislature convened by the president of the Utah Senate and speaker of the Utah House of Representatives. The Amendment changes the limit on the amount of money that the Legislature may appropriate during a session convened by the Senate president and House speaker.

Background

In 2018, the Utah Legislature passed, and the voters approved, an amendment to the Utah Constitution allowing the president of the Utah Senate and the speaker of the Utah House of Representatives to convene the Utah Legislature into special session under certain limited circumstances. The 2018 amendment limits the amount of money the Legislature may appropriate during one of those special sessions to an amount equal to 1% of the total amount appropriated for the immediately preceding fiscal year.

The 2018 amendment relates only to a special session of the Utah Legislature convened by the president of the Utah Senate and the speaker of the Utah House of Representatives. The 2018 amendment does not affect the amount of money that the Utah Legislature may appropriate during a special session convened by the governor under a separate provision of the Utah Constitution.

Effect of Constitutional Amendment A

Constitutional Amendment A changes the language of the Utah Constitution relating to the amount of money that the Utah Legislature may appropriate during a special session convened by the Senate president and House speaker. The Amendment changes that language in two ways.

First, Amendment A increases the limit on the amount of money the Utah Legislature may appropriate during a special session convened by the Senate president and House speaker. The Amendment increases that limit from an amount equal to 1% of the amount appropriated for the immediately preceding fiscal year to an amount equal to 5% of the amount appropriated for the immediately preceding fiscal year. For example, the total amount appropriated for the fiscal year ending June 30, 2022 is \$27.7 billion. Under Constitutional Amendment A, if the Senate president and House speaker convene a special session before June 30, 2023 (the end of the next fiscal year), the amount that the Utah Legislature could appropriate during the special session would be limited to \$1.385 billion. Without Amendment A, the limit would be \$277 million.

CONSTITUTIONAL AMENDMENT A

Second, Amendment A states that the 5% limit does not apply to two items. The 5% limit does not apply to: (1) an appropriation of money that the federal government provides to the state to address a fiscal, public health, or other emergency or crisis; and (2) an appropriation that decreases the amount of money previously authorized to be spent.

Like the 2018 amendment mentioned in the Background section above, Constitutional Amendment A does not affect the amount of money that the Utah Legislature may appropriate during a special session convened by the governor under a separate provision of the Utah Constitution.

Effective Date

If approved by voters, Constitutional Amendment A takes effect January 1, 2023.

PROPOSAL TO AMEND UTAH CONSTITUTION - SPECIAL SESSION APPROPRIATIONS

2021 GENERAL SESSION

Utah Constitution Sections Affected:

AMENDS:

ARTICLE VI, SECTION 2

Be it resolved by the Legislature of the state of Utah, two-thirds of all members elected to each of the two houses voting in favor thereof:

Section 1. It is proposed to amend Utah Constitution, Article VI, Section 2, to read:

Article VI, Section 2. [Time and location of annual general sessions -- Location of sessions convened by the Governor or Legislature -- Sessions convened by the Legislature.]

(1) Annual general sessions of the Legislature shall be held at the seat of government and shall begin on the day in January designated by statute.

(2) A session convened by the Governor under Article VII, Section 6 and a session convened by the Legislature under Subsection (3) shall be held at the seat of government, unless convening at the seat of government is not feasible due to epidemic, natural or human-caused disaster, enemy attack, or other public catastrophe.

(3) (a) The President of the Senate and Speaker of the House of Representatives shall by joint proclamation convene the Legislature into session if a poll conducted by the President and Speaker of their respective houses indicates that two-thirds of all members elected to each house are in favor of convening the Legislature into session because in their opinion a persistent fiscal crisis, war, natural disaster, or emergency in the affairs of the State necessitates convening the Legislature into session.

(b) The joint proclamation issued by the President and Speaker shall specify the business for which the Legislature is to be convened, and the Legislature may not transact any business other than that specified in the joint proclamation, except that the Legislature may provide for the expenses of the session and other matters incidental to the session.

(c) The Legislature may not be convened into session under this Subsection (3) during the 30 calendar days immediately following the adjournment sine die of an annual general session of the Legislature.

(d) (i) In a session convened under this Subsection (3), the cumulative amount of [appropriations that the Legislature makes] additional money appropriated by the Legislature may not exceed an amount equal to [1%] 5% of the total amount appropriated by the Legislature for the immediately preceding completed fiscal year.

(ii) The limit in Subsection (3)(d)(i) does not apply to:

(A) an appropriation that decreases the amount of money authorized for expenditure in a fiscal year; or

(B) an appropriation of money that the federal government provides to the State to address a fiscal, public health, or other emergency or crisis.

(e) Nothing in this Subsection (3) affects the Governor's authority to convene the Legislature under Article VII, Section 6.

Section 2. **Submittal to voters.**

The lieutenant governor is directed to submit this proposed amendment to the voters of the state at the next regular general election in the manner provided by law.

Section 3. **Contingent effective date.**

If the amendment proposed by this joint resolution is approved by a majority of those voting on it at the next regular general election, the amendment shall take effect on January 1, 2023.

HOW DOES UTAH CHOOSE JUDGES?

The Utah Constitution states: "Selection of judges shall be based solely upon consideration of fitness for office without regard to any partisan political consideration." To fulfill this mandate, Utah selects its state court judges through a process called Merit Selection.

Merit Selection involves four steps: 1) nomination, 2) appointment, 3) confirmation, and 4) retention election. A committee of lawyers and non-lawyers selected by the Governor reviews judicial applications, conducts interviews, and then nominates the five best-qualified applicants for each trial court judgeship and the seven best-qualified applicants for each appellate court judgeship. The Governor then interviews all nominees and appoints one, who must then be confirmed by a majority of the Utah State Senate.

After confirmation and the first three years of service, the new judge's name appears on the ballot for a "yes" or "no" retention vote by the public to determine whether the judge may serve another term of office. Supreme Court justices serve 10-year terms; all other judges serve six-year terms.

Why does Utah use Merit Selection? This method of selecting judges is widely considered the best way to balance the need for judges to be accountable to the public with the equally important need for the judiciary to function independently. Judges serve the public and should answer to the public. That's why Utah has retention elections – to give every citizen the right to weigh in on judges. Of equal importance, though, every judge must resolve disputes impartially and make decisions based only on the facts and the law. To do so, judges must be insulated from public pressure and politics. That's why all judicial candidates are non-partisan and why Utah does not have contested elections for judgeships.

WHAT EXACTLY ARE JUDICIAL RETENTION ELECTIONS?

- If a judge seeks an additional term of office, the Utah Constitution requires that the judge run in a retention election. In that election, a simple majority of "yes" votes earns the judge another term in office.
- The retention election helps keep judges independent by insulating them from partisan politics. At the same time, by allowing every voter to weigh in, the election process ensures that judges remain accountable to the public. To cast an informed vote, the public can first read about the judges either in the Voter Information Pamphlet or online at judges.utah.gov or vote.utah.gov.

HOW DOES UTAH EVALUATE ITS JUDGES?

- The Judicial Performance Evaluation Commission is an independent, 13-member group of lawyers and non-lawyers. Each of the three branches of government appoints an equal number of its members.
- The Commission must by law evaluate all judges twice during their terms of office. The first evaluation gives the judges the opportunity for self-improvement. The second evaluation gives the public information to use in casting their votes. As part of the second evaluation, the Commission votes on whether or not to recommend the judge for another term in office. Sometimes, the votes will not total 13. This happens when a commissioner does not vote because of personal or professional relationships with a judge that could affect an unbiased evaluation or when a commissioner is absent from the meeting at which the vote is taken...

- The evaluation includes several elements. Online surveys are sent to attorneys, court staff, and jurors. In addition, trained courtroom observers spend a minimum of two hours in each judge's courtroom and submit written reports of their observations on each judge. Each judge must also meet ethical standards as well as court standards for judicial education, timeliness, and fitness to serve. Finally, the Commission considers comments submitted to judges.utah.gov from members of the public who have first-hand experience with a judge. The Commission considers all this information, and then each commissioner casts a vote either for or against recommending the judge for another term of office.
- By law, judges have the right to see the results of their evaluation before making the decision to run for another term of office in a judicial retention election. If the judge chooses to run for retention election, the report on the judge is made available to the public in the Voter Information Pamphlet and online at judges.utah.gov. If the judge chooses not to run for retention election, the evaluation is, by law, a protected record.

WHAT CRITERIA MUST A JUDGE MEET TO "MEET OR EXCEED MINIMUM PERFORMANCE STANDARDS?"

If a judge meets the eight performance standards in the table below, it is presumed that the Commission will recommend that the voters retain the judge for another term of office. If the judge fails to meet the standards, it is presumed that the Commission will not recommend retention. If the Commission does not go along with a presumption or chooses to make no retention recommendation at all, it must explain in detail the reasons for its action.

WHAT ABOUT JUSTICE COURT JUDGES?

Justice court judges are selected through a merit selection process roughly similar to state court judges, except that the appointing authority is the municipality or county rather than the governor. Justice court judges serve six-year terms of office and stand for retention elections like state court judges. Justice courts vary widely in terms of case loads and the numbers of attorneys appearing in the court. Based on this variation, there are three levels of evaluations to which a justice court judge may be subject.

- Full evaluation: These justice court judges preside over the courts with the highest caseloads and are thus subject to the same standards and evaluation measures as state court judges (#1-8 below). Fourteen justice court judges on the ballot received a full evaluation in 2022.

- Mid-level evaluation: These justice court judges preside over medium-sized courts where fewer attorneys appear regularly. The mid-level evaluation includes interviews with court users, including litigants and those who accompany them to court, attorneys, court staff, interpreters, bailiffs and others. These judges must also meet judicial discipline standard (#5 below) and performance standards established by the Judicial Council (#6- 8 below). Ten justice court judges on the ballot received a mid-level evaluation in 2022.
- Basic evaluation: These justice court judges preside over the smallest courts in Utah. They must meet judicial discipline standard (#4 below) and performance standards established by the Judicial Council (#6-8 below). Seven justice court judges on the ballot received a basic evaluation in 2022. Some justice court judges have multiple courts and retention election years. For these judges, JPEC selects one retention election year as the "controlling cycle" and conducts its evaluations as if all the judge's courts had the same election year. As a consequence, JPEC reuses a judge's prior evaluation for this year's election for a small number of judges (five in 2022).

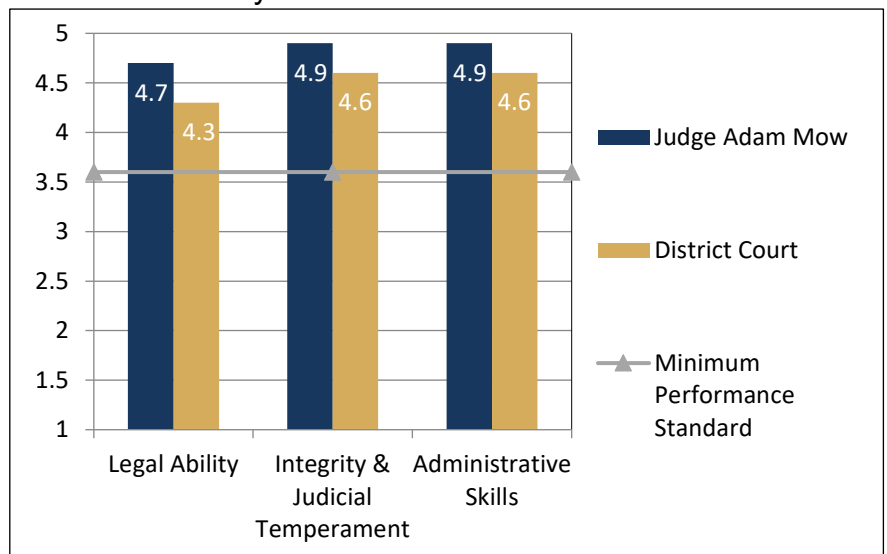


Honorable Adam Mow

Recently appointed in 2018, Judge Adam Mow's scores are statistically well above average on integrity and judicial temperament, administrative skills, and procedural fairness and above the average of his district court peers on legal ability. All fifty-nine respondents (100%) recommend that Judge Mow be retained. Although still somewhat new to the bench, respondents view him as a highly-skilled and fair judge who adheres to the law. One describes him as a "model judge," while another states that he "has all the skills I would expect to see in the best judges." 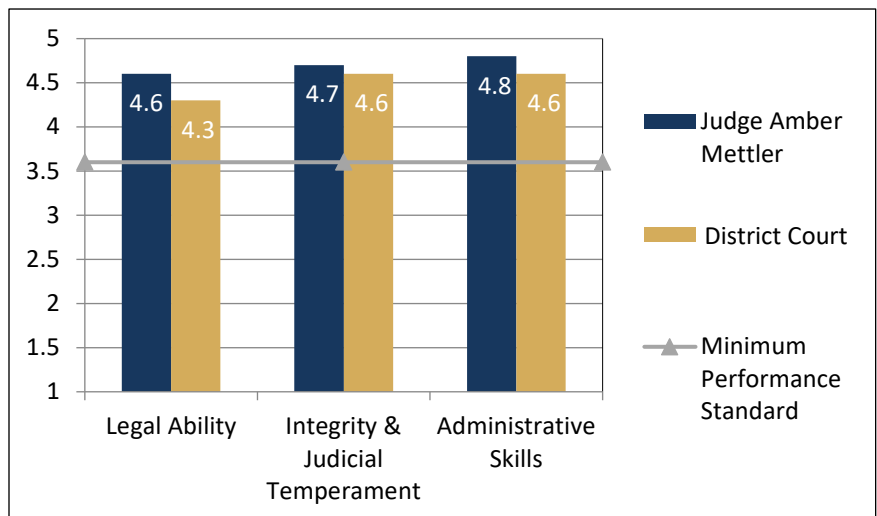

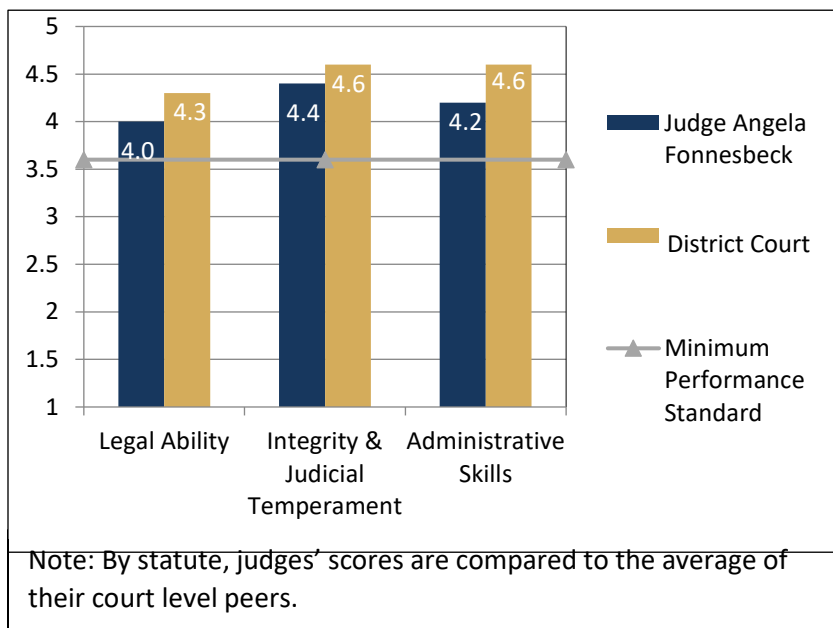

Appointed to the district court bench in 2019, Judge Angela Fannesbeck's scores are statistically consistent with her district court peers on legal ability, integrity and judicial temperament, and procedural fairness, and below the peer average on administrative skills. Eighty-five percent of survey respondents recommend that Judge Fannesbeck be retained. Respondents and courtroom observers, alike, praise the judge for her personable and pleasant demeanor and her professionalism while in court. Some respondents advise that this relatively new judge is still coming up to speed and suggest she work on her time management skills. All observers report confidence that they would be treated fairly if they were to appear in Judge Fannesbeck's court. This judge meets discipline standards set by statute and has been certified by the Judicial Council as meeting all time standards, education requirements, and mental and physical competence standards.

Judge Angela F. Fannesbeck was appointed to the First District Court in August 2019 by Governor Gary R. Herbert. In October 2014 she was appointed to the First District Juvenile Court. Judge Fannesbeck received her law degree from American University in 2000 and received a B.A. in Politics and Asian Studies from Whitman College in 1997. Prior to appointment, Judge Fannesbeck primarily practiced in the areas of family and criminal law. Judge Fannesbeck currently presides over the Mental Health Court and serves on both the Standing Committee on Education and the Uniform Fine Committee. 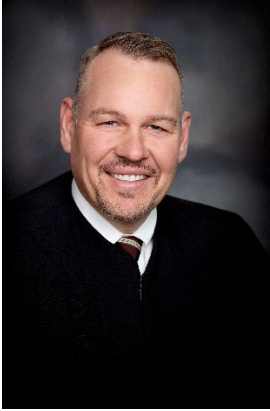
Recently appointed in 2018, Judge D. Scott Davis passes all minimum requirements, leading most of the Commission to find that he meets or exceeds performance standards. However, the Commission has concerns with the judge's performance. Upon reviewing the information collected in the evaluation and meeting with the judge, most commissioners find that the judge is aware of the concerns and has a plan in place to make improvements to address the concerns outlined below. Judge Davis's scores are statistically well below the average of his juvenile court peers on integrity and judicial temperament and procedural fairness, below the peer average on administrative skills, and statistically consistent with his peers on legal ability. Sixty-three percent of survey respondents recommend that Judge Davis be retained, which is lower than the average recommendation of 91% for his juvenile court peers. Respondents recognize the judge's dedication and commitment to his role. However, "when under time constraints" or when he "seems pressured," many indicate that he can lose his temper, which can "feel very pointed and demeaning to attorneys, clerical staff and the clients [e.g., youth and families] themselves." Some respondents also suggest that his personal life or beliefs may impair his judicial performance. Survey ratings of judicial attributes characterize Judge Davis as particularly disrespectful and impatient, as well as less attentive, capable, impartial, knowledgeable, and open-minded than his peers. Three of four observers report confidence that they would be treated fairly if they were to appear in Judge Davis's court.

This judge meets discipline standards set by statute and has been certified by the Judicial Council as meeting all time standards, education requirements, and mental and physical competence standards.

Judge D. Scott Davis was appointed to the Fourth District Juvenile Court in June 2018 by Governor Gary R. Herbert. He currently serves Utah and Millard counties. He received a bachelor's degree from Brigham Young University, and a Juris Doctor degree from the University of Puget Sound School of Law in 1983. He practiced law in Alaska, where he was raised, for 17 years in both private and government sectors. He moved to Utah in July of 2000, and was admitted to the Utah Bar Association 2-3 months later. Appointed in 2007, Judge Robert P. Faust passes all minimum requirements, leading most of the Commission to determine that the judge meets or exceeds performance standards. However, the Commission has concerns with the judge's performance. Upon reviewing the information collected in the evaluation and meeting with the judge, most commissioners find that the judge is aware of the concerns and has a plan in place to make improvements to address the concerns outlined below. Judge Faust's scores are statistically below his district court peers on legal ability, integrity and judicial temperament, and procedural fairness and consistent with his peers on administrative skills. Sixty-nine percent of survey respondents recommend that Judge Faust be retained, which is lower than the average recommendation of 88% for his district court peers. Judge Faust's review is mixed. Some respondents describe him as kind and seasoned, and many, along with courtroom observers appreciate the judge's efficiency and calendar management. However, many attorney respondents report concerns that the judge "too often... shoots from the hip and ignores the law" and renders "unreasonable rulings." Many suggest that his personal life or beliefs may impair his performance, and a few feel that he "has already made up his mind prior to taking the bench." Further, a few respondents and observers comment on the judge's tendency to "rush cases through" the legal process. Survey ratings of judicial attributes characterize Judge Faust as more disrespectful and impatient, as well as less prepared, attentive, capable, knowledgeable, open-minded, and impartial, than his peers. All observers report confidence that they would be treated fairly if they were to appear in Judge Faust's court. This judge meets discipline standards set by statute and has been certified by the Judicial Council as meeting all time standards, education requirements, and mental and physical competence standards.

Judge Robert P. Faust was appointed to the Third District Court in January 2007 by Gov. Jon M. Huntsman, Jr. After graduating from the J. Reuben Clark College of Law in 1982, he maintained a diverse litigation practice at Nielsen & Senior. After 1996, Judge Faust practiced law for the U.S. Postal Service and served as a Special Assistant U.S. Attorney. He served on the Utah Supreme Court Ethics & Discipline Committee and the Task

Force on Bar Governance Committee and was President of the Federal Bar Association. Judge Faust was a member of the Federal Bar Foundation, American Trial Lawyers Association, American Bar Association Litigation Section, and the Utah State Bar Litigation Section. Judge Faust now serves as a Utah judicial delegate to the American Bar Association.

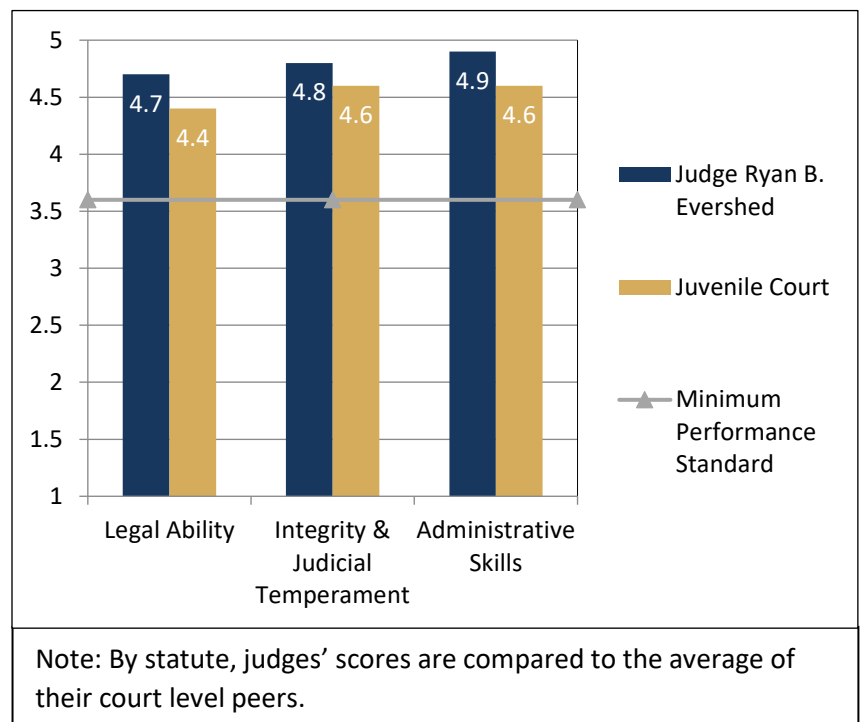

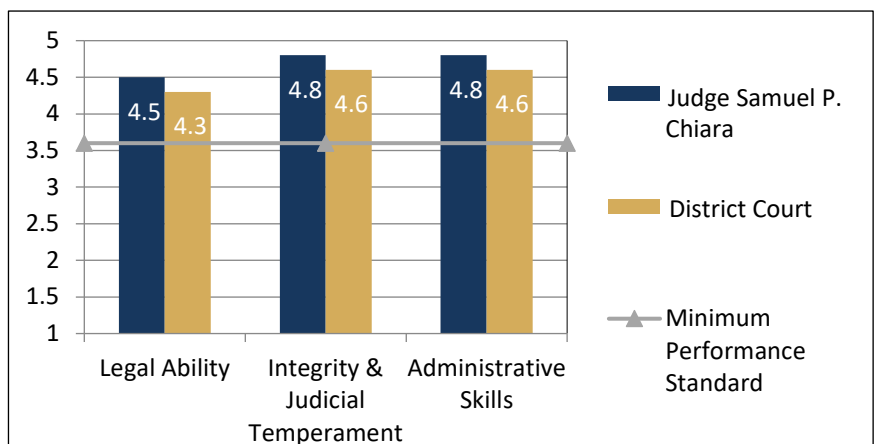

The appellate process reviews individual decisions. Judicial misconduct is investigated by the Utah Judicial Conduct Commission.

Judge Samuel P. Chiara was appointed to the Eighth District Court by Governor Gary Herbert in 2013. Judge Chiara earned a Bachelor of Science degree from the Marriott School of Management at BYU. He graduated magna cum laude from J. Reuben Clark Law School (BYU) in 1997. Prior to his appointment he practiced civil and criminal law and served as defense counsel for the Carbon County Drug Court. Judge Chiara was awarded the Utah State Bar Litigation Section Judicial Excellence Award in 2016, 2017, 2018, 2020, and 2021. 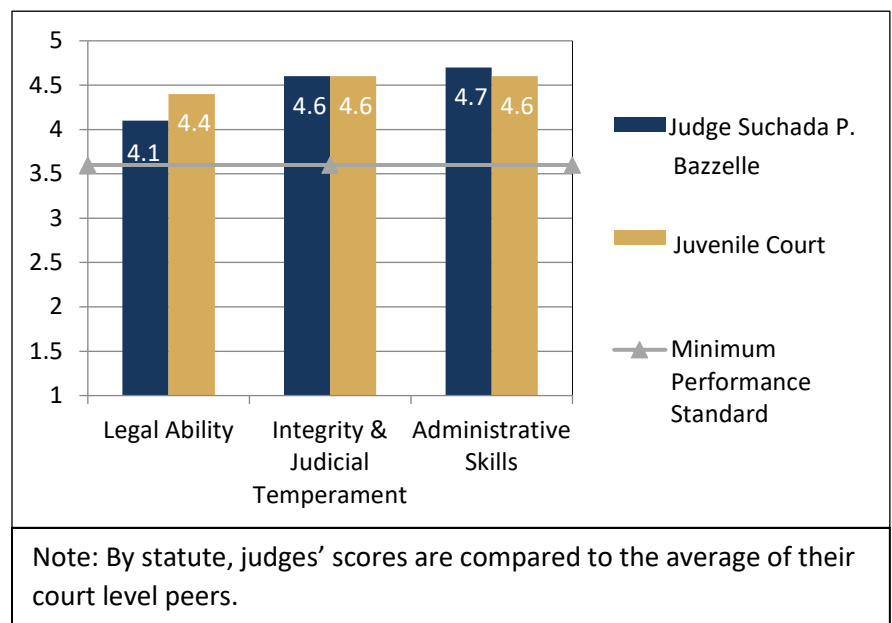

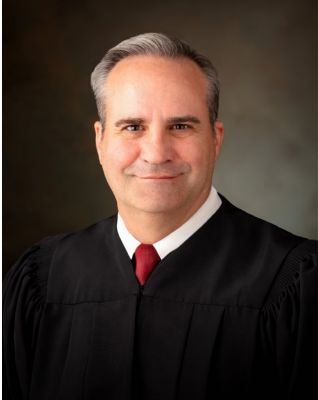

She is currently operating a Safe Babies Court, which is a pilot program focusing on better serving children zero to three years of age.

All courtroom observers expressed confidence that they would be treated fairly if they were to appear in Judge Peters' court, although one observer expressed tentative confidence. This judge meets discipline standards set by statute and has been certified by the Judicial Council as meeting all time standards, education requirements, and mental and physical competence standards.

Judge Katherine Peters was appointed to the Salt Lake City Justice Court in 2019. She earned a law degree from Chicago-Kent College of Law in 2001. After a brief period at a prominent civil litigation firm with a focus on property-tax litigation, Judge Peters served as a Deputy District Attorney for Salt Lake County for seventeen years. As a Deputy District Attorney, Judge Peters competently and diligently managed a wide variety of cases, ranging from misdemeanor offenses to violent felonies, homicide, and sexual offenses, including numerous high-profile cases. Judge Peters has worked in both adult and juvenile court settings. Judge Peters currently serves on the JPEC Juror Survey Subcommittee and previously served on the Self-Represented Parties Committee.

The Commission expressed some concerns with the judge's performance; however, upon meeting with the judge, it is satisfied that the judge is aware of the concerns and has a plan in place to make improvements to address the concerns outlined below. Seventy-seven percent of survey respondents recommend that Judge Magid be retained. Respondents note Judge Magid's skill in following judicial procedure and they, along with courtroom observers, appreciate her ensuring litigants' understanding of the process. Survey ratings of judicial attributes characterize Judge Magid as more disrespectful than her peers. Respondents suggest that her personal life and/or beliefs may impair her judicial performance, and a few comment that she tends to favor certain parties to the extent that "attorneys ... joke about it in the courtroom." All observers report confidence that they would be treated fairly if they were to appear in Judge Magid's court. This judge meets discipline standards set by statute and has been certified by the Judicial Council as meeting all time standards, education requirements, and mental and physical competence standards.

Judge Sydney Magid was appointed to the Salt Lake City Justice Court in 2004. She received a Bachelor of Arts in Mass Communications from the University of Massachusetts at Amherst in 1990 and a Juris Doctorate from the University of Utah College of Law in 1993 where she was a William H. 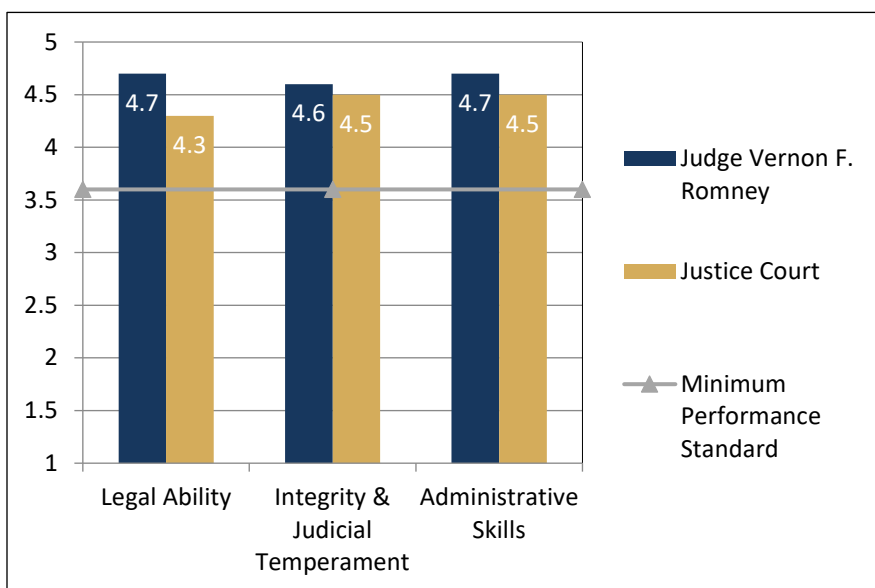

Appointed in 2007, Judge Vernon F. Romney's scores are statistically above the average of his justice court peers on legal ability, and consistent with his peers on integrity and judicial temperament, administrative skills, and procedural fairness. Ninety-four percent of survey respondents recommend that Judge Romney be retained. Respondents and courtroom observers value the judge's timeliness and demeanor, describing him as calm, level-headed, and possessing common sense. Respondents also praise Judge Romney for his understanding of the law. Survey ratings of judicial attributes characterize Judge Romney as particularly capable, ethical, and knowledgeable, as well as notably respectful and prepared. While four of five observers report confidence that they would be treated fairly if they were to appear in Judge Romney's court, one observer does not express confidence. This judge meets discipline standards set by statute and has been certified by the Judicial Council as meeting all time standards, education requirements, and mental and physical competence standards.

Judge Vernon F. Romney was appointed to the Provo City Justice Court bench in July 2007. He graduated from Brigham Young University with a degree in English in 1979 and a law degree in 1982. Prior to his appointment to the bench, Judge Romney worked for 22 years in the Provo City attorney's office, at which time he served primarily as lead city prosecutor. Judge Romney has served as president of the Central Utah Bar Association, president of the Utah Municipal Prosecutor's Association, chair of the Fourth District Court's Victim's Rights Committee, as a member of the Utah Domestic Violence Council, and as a member of the training committee for the Utah Prosecution Council.

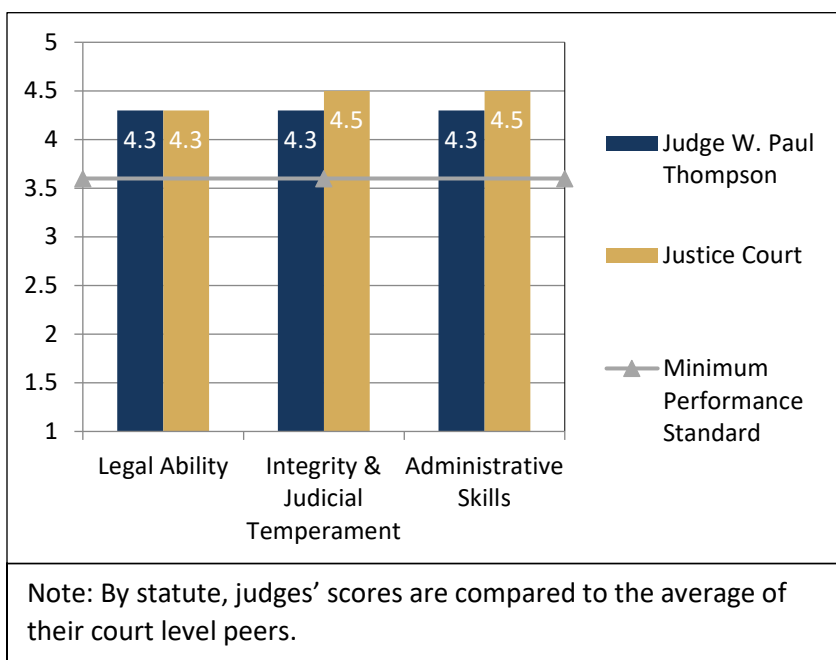

Judge Paul Thompson was appointed to the Murray City Justice Court in 2008. He has served as an active or senior judge since 1992. Judge Thompson received a degree from the J. Reuben Clark Law School at Brigham Young University in 1976. He served as the mayor of Sandy City from 1978 to 1982, and is a former city attorney for South Salt Lake, Alta, and South Jordan. Judge Thompson is a former chairman of the Salt Lake County Council of Governments, member of the Wasatch Front Regional Council, and trustee of the Salt Lake Convention and Visitors Bureau. He was the founding chairman of the Third Judicial District Victim's Rights Committee. Judge Thompson has been a member of the Utah State Bar since 1976.

Vote by mail

(Postmark your ballot by November 7th)

- All counties will be conducting the election by mail.
- All active voters will be mailed a ballot beginning October 18th. You can expect it shortly after.

If you forget to postmark your ballot by November 7th, you can drop your ballot off

- at your county clerk's office (page 125) or a polling location on Election Day.

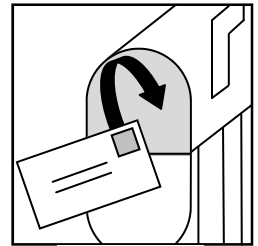
1. Follow the instructions on the ballot and mark your ballot.



2. After you have marked your ballot, place your ballot in the provided return envelope and seal the envelope.



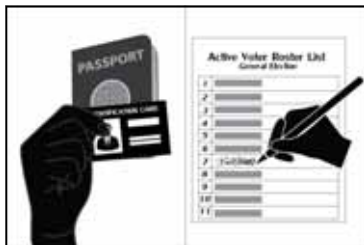
3. Sign the voter declaration on the envelope. **You must sign this declaration for your vote to count, and you can only sign your own envelope.**



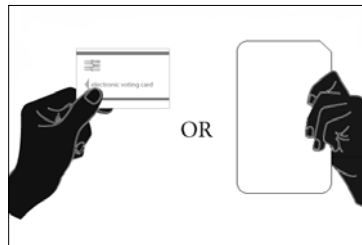

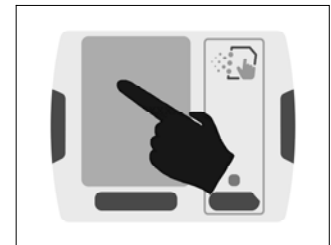
If you are voting in-person:



1. Present a valid form of I.D. to the poll worker and sign the official voting register.



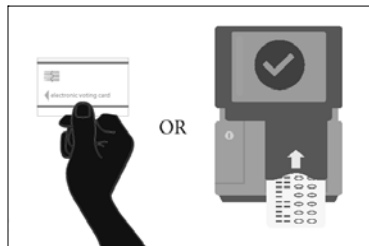
2. The poll worker will give you a card or a blank ballot to insert into an electronic voting machine, or you may receive a paper ballot to vote.

Am I eligible to register to vote?

You are eligible to register to vote if you:

- Are a citizen of the United States
- Have resided in Utah for at least 30 days immediately before the next election
- Are at least 18 years of age on or before the next election*
- If you are 16 or 17 years of age, you may preregister to vote.

*A voter who is 17 years of age is eligible to participate in a Primary Election if they will turn 18 years of age on or before the date of the next General Election.

When is the voter registration deadline?

This registration form must be received by your county clerk's office at least 11 days before the election. If this form is not received by this deadline, you may register to vote at a voting center by voting with a provisional ballot and providing two forms of identification. You can find a list of acceptable forms of identification at www.vote.utah.gov.

How will I know if my registration was processed?

Your county clerk's office will send you an official voter information card by mail within 30 days of processing your voter registration form. You can also check the status of your voter registration by visiting www.vote.utah.gov.

Will I need identification to vote?

Yes, you will need to provide identification if you vote in person. If you are registering to vote for the first time and are voting by mail, you will need to provide identification to your county clerk's office. A list of acceptable forms of identification can be found at www.vote.utah.gov.

Will I get a ballot in the mail?

If this form is received by your county clerk's office at least 11 days before an election, your county clerk's office will mail you a ballot. If you are unable to submit your registration at least 11 days before an election, you must vote at an in-person voting center.

You can find a nearby voting center on www.vote.utah.gov.

Can I register to vote if I have been arrested or convicted of a crime?

You can register to vote if you:

- Are granted parole;
- Are on probation for a misdemeanor or a felony;
- Are a pretrial detainee awaiting trial;
- Are currently in jail serving a sentence for a misdemeanor that is not related to election law; or
- Are no longer serving a term of imprisonment due to a felony or misdemeanor conviction.

Is voter registration information confidential?

The list of registered voters is considered public record and available to the general public in Utah. However, Utah law grants protections to voters who wish to not have their information publicly available. "Section 10" of the Voter Registration Form allows for a voter to protect their information from certain parties, while the section below (titled "How do I request additional privacy protection?") discusses additional privacy protections that are available to certain individuals. A few items remain confidential and are never provided to any requester: your social security number, your UT Driver's License number/UT ID number, email address, full date of birth, phone number and your signature.

How do I request additional privacy protection?

In addition to the protections outlined in "Section 10" of the Voter Registration Form, you may request that all information on your voter registration records be withheld from all political parties, candidates for public office, and their contractors, employees, and volunteers, by submitting a withholding request form, and any required verification, with this registration form, or to the Office of the Utah Lieutenant Governor or a county clerk.

Who can submit a withholding request form?

- A person who is a victim, or is likely to be a victim, of domestic violence or dating violence
- Law enforcement officers
- Individuals protected by protective or protection orders
- Members of the armed forces
- Public figures who have a higher safety risk due to their celebrity status or prominent position (does not include elected officials)
- A person who resides with a person described in the bullet points above.

You can obtain a withholding request form from your county clerk's office or the Office of the Utah Lieutenant Governor, or you may download the form online at www.vote.utah.gov.

How do I vote if I'm a Utah resident but live outside of the state at the time of an election?

If you are a Utah resident who is actively serving military duty or currently resides outside of the U.S., complete "Section 8" of the Voter Registration Form to be eligible to receive a ballot by fax or email. If you are a Utah resident and would prefer to not receive your ballot at your primary residence, you can obtain an "Alternate Address Request Form" online at www.vote.utah.gov and submit it to your county clerk's office. This will enable you to receive your by-mail ballot at a separate address from your primary residence.
